- 1 CONCERNED WITH THESE ISSUES.
- 2 FIRST AND FOREMOST IS THE ISSUE OF IDENTITY.
- 3 THE STATE OF WEST VIRGINIA WOULD HAVE TO ESTABLISH THAT
- 4 YOU ARE THE SAME ROBERT JOSEPH FERRANTE NAMED AND
- 5 DESCRIBED IN THIS PAPERWORK ARISING FROM ALLEGHENY
- 6 COUNTY, PENNSYLVANIA.
- 7 SECONDLY, I WOULD LOOK AT THE NATURE OF THE
- 8 CHARGE IN THIS CASE. AND THE CHARGE THAT WE ARE
- 9 ADDRESSING IS COMMITTING CRIMINAL HOMICIDE. I HAVE TO
- 10 MAKE SURE THAT THAT IS A LEGITIMATE CHARGE. THAT IT IS
- 11 NOT SOMETHING THAT IS MADE UP OR ASSERTED WITHOUT CARE
- 12 OR WARRANT.
- 13 THIRDLY, IS THE ISSUE OF OPPORTUNITY. YOU WOULD
- 14 HAVE HAD TO HAVE BEEN IN ALLEGHENY COUNTY IN AND ABOUT
- 15 THE TIME OF THE CHARGE IN ORDER TO HAVE PRESUMABLY
- 16 COMMITTED AN OFFENSE. OR YOU WOULD HAVE HAD TO HAVE HAD.
- 17 SOME DEALING WITH ALLEGHENY, PENNSYLVANIA IN AND ABOUT
- 18 THAT TIME. SO THE STATE OF WEST VIRGINIA WOULD HAVE TO
- 19 DEAL WITH THE ISSUE OF OPPORTUNITY AND PROVE IT TO THIS
- 20 COURT'S SATISFACTION AS THE THIRD PRONG OF THIS TEST.

- 21 NOW, WHAT I WOULD NOT BE CONCERNED WITH IS
- 22 WHETHER OR NOT YOU ARE GUILTY OR NOT GUILTY OF
- 23 COMMITTING CRIMINAL HOMICIDE, BECAUSE THAT IS SOMETHING
- 24 FOR THE COMMONWEALTH TO DETERMINE. I MERELY HAVE TO
- 25 DETERMINE WHETHER OR NOT TO SEND YOU BACK TO THE

- 1 COMMONWEALTH TO FACE THOSE CHARGES THERE.
- 2 SIR, DO YOU UNDERSTAND THE RIGHTS THAT I HAVE
- 3 EXPLAINED TO YOU?
- 4 MR. FERRANTE: YES, SIR.
- 5 THE COURT: NOW HAVING EXPLAINED YOUR RIGHTS, DO
- 6 YOU STILL WISH TO WAIVE EXTRADITION AND TO RETURN
- 7 VOLUNTARILY TO THE COMMONWEALTH OF PENNSYLVANIA.
- 8 MR. FERRANTE: YES, SIR.
- 9 THE COURT: ALL RIGHT. I AM NOT ASKING YOU TO
- 10 PLEAD GUILTY TO ANYTHING, BUT I ASK YOU NOW IF YOU
- 11 BELIEVE YOU ARE THE SAME ROBERT JOSEPH FERRANTE NAMED
- 12 AND DESCRIBED IN THIS PAPERWORK?
- 13 MR. FERRANTE: YES. SIR.
- 14 THE COURT: AND AM I PRONOUNCING YOUR LAST NAME

- 15 CORRECTLY?
- 16 MR. FERRANTE: YES, SIR.
- 17 THE COURT: I HAVE PREPARED FOR YOUR
- 18 CONSIDERATION A WAIVER OF EXTRADITION AND I WILL READ IT
- 19 INTO THE RECORD NOW. IF YOU HAVE ANY QUESTIONS ABOUT
- 20 IT, I'LL BE HAPPY TO ANSWER THEM, AND OF COURSE, YOU CAN
- 21 CONFER WITH YOUR ATTORNEY, MS. HEBB ABOUT THE WAIVER IF
- 22 YOU HAVE ANY QUESTIONS OF HER.
- 23 IT IS ENTITLED WAIVER OF EXTRADITION. STATE OF
- 24 WEST VIRGINIA, COUNTY OF RALEIGH, TO WIT, IT STATES AS
- 25 FOLLOWS:

- 1 I, ROBERT JOSEPH FERRANTE, NOW IN CUSTODY BEING
- 2 CHARGED WITH COMMITTING CRIMINAL HOMICIDE IN THE STATE
- 3 OF PENNSYLVANIA HAVING BEEN INFORMED BY THE JUDGE OF THE
- 4 CIRCUIT COURT IN THE COUNTY AND STATE AFORESAID OF MY
- 5 RIGHTS WITH RESPECT TO THE ISSUANCE AND SERVICE OF A
- 6 WARRANT OF EXTRADITION AND WITH RESPECT TO OBTAINING A
- 7 WRIT OF HABEAS CORPUS UNDER PROVISIONS OF LAW, DO HEREBY

- 8 WAIVE THE ISSUANCE AND SERVICE OF AN EXTRADITION WARRANT
- 9 AND ALL OTHER PROCEDURE INCIDENTAL TO EXTRADITION AND
- 10 FREELY AND VOLUNTARILY CONSENT TO RETURN TO THE STATE OF
- 11 PENNSYLVANIA IN COMPANY WITH THE AGENT THEREOF TO ANSWER
- 12 THE AFORESAID CHARGES THERE PENDING AGAINST ME.
- NOW, DR. FERRANTE, DO YOU HAVE ANY QUESTIONS
- 14 ABOUT THIS PROPOSED WAIVER?
- DR. FERRANTE: NO, SIR.
- 16 THE COURT: ALL RIGHT. I WOULD ASK THE BAILIFF
- 17 TO DELIVER THE WAIVER TO COUNSEL TABLE SO IT MAY BE
- 18 EXECUTED IN OPEN COURT PLEASE.
- 19 (THE DEFENDANT SIGNS THE DOCUMENT.)
- 20 (THE COURT SIGNS THE DOCUMENT.)
- 21 THE COURT: ALL RIGHT. THE COURT RECEIVES THE
- 22 FULLY EXECUTED WAIVER OF EXTRADITION. IT IS MADE A PART
- 23 OF THIS RECORD AND CASE FILE.
- NOW, DR. FERRANTE, LET ME EXPLAIN TO YOU WHAT
- 25 WILL HAPPEN NOW. THE AUTHORITIES FROM PENNSYLVANIA HAVE

- 2 THE COMMONWEALTH. THE 10-DAY PERIOD STARTS TOMORROW.
- 3 IT INCLUDES SATURDAYS AND SUNDAYS AND ANY HOLIDAY THAT
- 4 MIGHT FALL WITHIN THE MIX. IF SOMEONE DOES NOT COME AND
- 5 GET YOU FROM THE SOUTHERN REGIONAL JAIL TO TAKE YOU BACK
- 6 TO PENNSYLVANIA WITHIN THE 10-DAY PERIOD, I WILL RELEASE
- 7 YOU OUTRIGHT AT THE CLOSE OF THE BUSINESS DAY ON THE
- 8 10TH DAY. SO THAT IS 4:30 ON THE 10TH DAY.
- 9 I SUSPECT IN THIS CASE THAT THE AGENTS FROM THE
- 10 COMMONWEALTH WILL BE HERE RATHER QUICKLY, POSSIBLY
- 11 TOMORROW OR THE NEXT DAY. BUT WE DON'T WANT YOU TO
- 12 LINGER HERE MORE THAN NECESSARY. AND SO IF YOU ARE HERE
- 13 10 DAYS, YOU WILL BE RELEASED IF THEY HAVE NOT COME TO
- 14 RETRIEVE YOU.
- 15 YOUR ATTORNEY WILL ADVISE YOU FURTHER IN THE
- 16 MATTER. SHE WILL GIVE YOU A CARD WHERE YOU CAN CALL HER
- 17 IF YOU HAVE ANY QUESTIONS. IF YOU DON'T HEAR ANYTHING
- 18 WITHIN THE 10-DAY PERIOD. IF SOMEONE HASN'T COME TO PICK
- 19 YOU UP AND TAKE YOU BACK TO PENNSYLVANIA, YOU SHOULD
- 20 CONSULT WITH YOUR ATTORNEY. COMPLAIN TO HER, SHE WILL
- 21 IN TURN COMPLAIN TO ME, AND I'LL TAKE APPROPRIATE
- 22 ACTION.

DO YOU HAVE ANY QUESTIONS, SIR? DR. FERRANTE: NO, SIR. THE COURT: ANYTHING FURTHER MS. HEBB? MS. HEBB: NO, YOUR HONOR. THANK YOU. THE COURT: ANYTHING, MR. DIMLICH. MR. DIMLICH: NO, JUDGE. THE COURT: VERY WELL. THIS HEARING IS 5 CONCLUDED.
